( \_\_\_\_\_ ) - **REAR PASSENGER SEATBELT VIOLATION**: fail to wear a seat belt when seated in the rear seat of a motor vehicle in motion.

( \_\_\_\_\_ ) - **UNSAFE MOVEMENT**: operate a motor vehicle on a public street/highway before starting, stopping, or turning from a direct line without first seeing and/or signaling that such a movement could be made safely.

( \_\_\_\_\_ ) - **DISMISSAL OF RELATED OFFENSE ON SAME FILE NUMBER**: Pursuant to the above amendment of the charges, the State dismisses the remaining charge in this file number.
